



MINUTES – GENERAL MEMBERSHIP MEETING

The BASCW General Membership meeting was held on September 20, 2025, at the Sports Pavilion, Sun City West, Arizona.

1. **Establish quorum and call to order** – There is a quorum, and meeting was called to order at 4:30.
2. **Minutes** – Reading of the Minutes from our last General Membership Meeting was waived.
3. **Treasurer Report** – Bank balance as of August 31, 2025, was \$4,339.19.
4. **Membership Report** – The current membership is 296 members.
5. **Old Business:**
 - a. **Annual Hall of Fame (HOF) Awards Banquet** – Reminded the membership that the HOF Awards Banquet date was changed to 4:00 p.m. on Saturday, November 15, 2025, and would be held at the Social Hall in the SCW Administration Campus. It was also announced that the BASCW annual elections and next General Membership meeting would also be held at that time.
 - b. **Upcoming Board Vacancies** – Informed the membership that Bob Engen’s term expires at the end of the year and that anyone interested in a position on Board should contact Sheri Gingerich, Nominations Chair.
 - c. **Summer Red Pin (SRP) No-tap Series:**
 - i. It was reported that the SRP series concluded with 86 members participating throughout the summer. The 20-week series ran from April 15, 2025, through August 26, 2025.
 - ii. The Board approved and implemented a new playoff structure for the summer series. The six female and six male bowlers with the highest averages competed against each other for cash prizes. The top female bowler (Sheri Gingerich) bowled against the top male bowler (Tom Skagen) for the title of Summer Red Pin Series Grand Champion. Tom Skagen was crowned the Grand Champion. Also, congratulations to Tom for bowling three consecutive “300” games for a “900” series during the initial playoff round.

6. **New Business:**

- a. **Bowling Center Remodeling/Upgrades** – The bowling center will be getting new pinsetters installed somewhere in the vicinity of April 21, 2026. During that time, half of the lanes will be closed to accomplish the work. Bowling will be limited to open bowling on those lanes only during the upgrade period. There will be no BASCW no-tap events (or league play) from April 21, 2026, through June 13, 2026. BASCW no-tap events will resume on Saturday, June 27, 2026.

7. **President's Remarks:**

- a. The Arizona Fire & Medical Authority requested and was granted permission to address the membership regarding services they provide to the community, but their representative did not show up.
