



MINUTES – GENERAL MEMBERSHIP MEETING
in conjunction with the Annual Hall of Fame and Awards Banquet
Held at RH Johnson Social Hall
19803 N RH Johnson Blvd Sun City West, AZ 85375
Saturday, November 15, 2025 – 4:30 pm

1. **Establish quorum and call to order** – There is a quorum, and meeting was called to order at 4:30.
2. **Minutes** – Reading of the Minutes from our last General Membership Meeting was waived.
3. **Treasurer Report** – Bank balance as of October 31, 2025, was \$7,681.40.
4. **Membership Report** – As of October 31st, we have a total of 256 members (74 members have not renewed).
5. **Old Business:**
 - a. **Election of Board Members** – An election ballot was distributed at the door as members arrived and they were asked to place their completed ballots in the box provided. (See page 3 for The Candidate Bios and page 4 for the Ballot.)
 - b. **Election Results** – Following dinner, the election results were announced as follows:
 - Kathleen Ashing (incumbent)
 - Linda Conklin
 - Teresa Hinojosa (incumbent)
 - c. **Newcomers Open House on October 22, 2025** – A few of the BASCW Board members worked the table to welcome Newcomers at the Open House. Several membership applications and club information pamphlets were distributed.
 - d. **Bowling Center Remodeling/Upgrades** – As a reminder, the bowling center will be getting new pinsetters installed somewhere in the vicinity of April 21, 2026. During that time, half of the lanes will be closed to accomplish the work in which bowling will be limited to open bowling on those lanes only. **There will be no BASCW no-tap events (or league play) from April 21st through June 13th.** If upgrades are completed on time, the BASCW no-tap events will resume on Saturday, June 27, 2026.
6. **New Business:**
 - a. **Amendment to the Club By-laws** – The Board will be submitting a proposal to the membership to amend Article IV (Club Board), Section B (Club Board Election), paragraph 2, to **increase the size of the Board from nine (9) members to twelve (12) members**. The proposed amendment shall also include **amending the election cycle of Board members from three Board members to four Board members to be elected each year**. The rationale for this amendment is to reduce the workload on current Board members resulting from the newly implemented split shift no-tap events and to cross-train more Board members in the duties and responsibilities involved in the operation of club activities, while maintaining continuity of knowledge and experience within the Board. Any amendment to the By-laws of this club requires a two-third vote of the membership present at a meeting specifically called for such purpose, a quorum being present. Procedures for filing amendments are as follows:

- 1) The Recreation Center’s “Recreation Activities Manager” shall review the proposed amendments prior to submittal to the Club Membership.
- 2) Proposed amendments shall be well publicized to the membership one (1) month prior to the vote.
- 3) All amendments must be voted upon and approved by a quorum of the membership.
- 4) A completed revised set of the Club’s By-laws will be submitted to the Recreation Center’s “Recreation Activities Manager” for final review.
- 5) The amended By-laws require the approval of the Recreation Center’s “General Manager” prior to implementation.
- 6) The results and date of the membership vote should be duly noted on the submittal document.

It is the Board’s hope that the aforementioned amendment filing procedures can be completed and submitted to the membership by the next General Membership Meeting.

- b. **Newcomers Open House on October 22, 2025** – A few of the BASCW Board members worked the table to welcome Newcomers at the Open House. Several membership applications and club information pamphlets were distributed.

7. **President’s Remarks** – Bob Bauer felt we had a very successful year. Some highlights are:

- a. The membership overwhelmingly voted to alternate lane assignments, so that you weren’t bowling next to the same people all the time to get a chance to meet new people.
- b. The Board is always looking to find different ways to make our bowling events more fun by implementing the following:
 - Bi-annual candlelight bowling events (next one is our New Year’s Red Pin on December 27, 2025).
 - Championship playoff format for the Tuesday Summer Red Pin Series.
 - Various special \$1.00 payout events.
 - Split-shift format for our Saturday bowling events. This has been a huge success by allowing more bowlers than ever to access opportunities to bowl.
 - Obtained use of the television behind the bowlers table in the bowling center for BASCW to display club news and information.

8. Next **General Membership Meeting** will be held on **Saturday, February 21, 2026**, in the RH Johnson Sports Pavilion at the conclusion of the 3:00 p.m. no-tap shift.

9. The General Membership Meeting was adjourned at 5:30 p.m.

10. Following the General Membership Meeting, the Hall of Fame and Awards Banquet was held.
